Specialty Vendors (No Limit) – Selling only one specialty item such as kettle corn, ice cream etc.

\$ 125.00 (1/2 price if paid by May 30th)

Local Non-Profit Organizations Special Rate:

\$ 100.00 (1/2 price if paid by May 30th)
